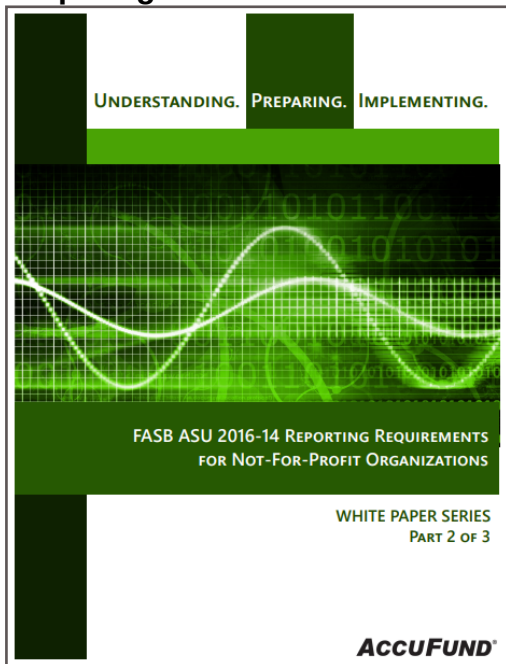


Preparing for the New FASB ASU 2016-14 Reporting Requirements.
